



Non-Disclosure & Registration Agreement

I understand and agree that Consultant has a contract with Seller for payment of its fees and commissions and agree not to circumvent that contract. The Seller pays all Consultant fees and commissions. I pledge that should I or the entities I represent buy, lease, become a manager of, become connected with in any way, or come into possession of any business introduced to me by Consultant within (2) years of the date below, even if the listing period has expired, that a commission will be due to Consultant and in the event of a breach of this agreement that I will be liable for the payment of that commission and all reasonable costs of collection, interest and attorney's fees.
